# FASTEN THE BELT. SECURE YOUR OPERATION.

Wearing a seat belt: **It's one of the easiest, most effective ways for equipment operators to stay safe.** Sometimes busy workers can forget or get distracted.

The **CAT® SEAT BELT REMINDER** prompts operators to buckle up and stay buckled all shift. That helps reduce the risk of injuries on your site — and shows your commitment to a **safety-first culture.** Depending on the type of work you do, it may also help you comply with regulations, avoiding shutdowns and fines.



## THE DIFFERENCE BETWEEN LIFE AND DEATH

Why is reminding operators to buckle up so important? After all, most machines don't travel very fast, and most come equipped with a rollover protection structure (ROPS).

**Here's why:** The U.S. Occupational Safety and Health Administration (OSHA) compared more than 50 rollover accidents involving machines with and without ROPS and operators with and without seat belts. Only when operators wore seat belts in a ROPS-protected cab were there zero fatalities.

## A SIMPLE, EFFECTIVE REMINDER

There's nothing complicated about the Cat Seat Belt Reminder. If an operator disengages the parking brake without first putting on the seat belt, that triggers an audible alarm in the cab and a light in the buckle. It also records an event in VisionLink®. There's an option to add an external beacon that alerts site managers, too. As soon as the operator buckles up, these alerts shut off.

## REAL-TIME SAFETY MONITORING



With equipment telematics, it's easy to keep track of how often the Cat Seat Belt Reminder is activated. Anytime an operator starts a machine or disengages the parking brake without first buckling up, Cat VisionLink records the event. That data is sent in real time to the Cat App and VisionLink, your online user interface. That way, you can keep track of how often seat belt violations occur and identify opportunities for operator training.



## A SOLUTION THAT WORKS ACROSS YOUR FLEET

Adding the Cat Seat Belt Reminder to operator and training/passenger seats in your equipment — Cat machines and other brands — is fast and easy. You can install it in 12- and 24-volt DC systems, and it typically takes less than two hours if you use existing seat belt mounting locations.
